## 4. First aid measures

### Description of necessary first aid measures

### Extinguishing media

**Specific hazards arising from the chemical** : Extremely flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion.
