## 2. Hazards identification

### Precautionary statements

## 4. First aid measures

### Description of necessary first aid measures

- Eye contact** : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention.

## 5. Fire-fighting measures

- Specific hazards arising from the chemical** : Extremely flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. ## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

### Precautions for safe handling

## 8. Exposure controls/personal protection

- Appropriate engineering controls** : Use only with adequate ventilation.
