4. First aid measures

5. Fire-fighting measures

Extinguishing media

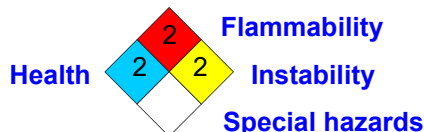
