### Personal precautions, protective equipment and emergency procedures

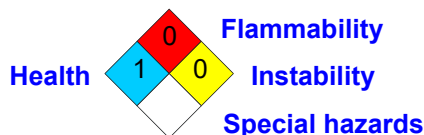
