### Description of necessary first aid measures

**Specific hazards arising from the chemical** : Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. ## 5. Fire-fighting measures

Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. ## 8. Exposure controls/personal protection

- Appropriate engineering controls** : Use only with adequate ventilation. 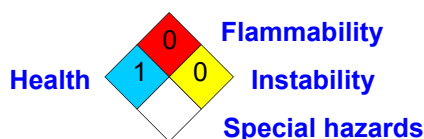
