Description of necessary first aid measures

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

7. Handling and storage

Precautions for safe handling

Extinguish candle by blowing gently. Always leave at least 20cm between burning candles. Do not use if the glass is damaged. People suffering from perfume sensitivity should be cautious when using this product. Air Fresheners do not replace good hygiene practices. Do not burn candles on or near anything that can catch fire. Do not use on hot surfaces e.g. T. V. Do not allow the flame to touch the side of the glass holder. Do not use the glass candle holder for drinking purposes or for storing food.
