4. First aid measures

Description of necessary first aid measures

7. Handling and storage

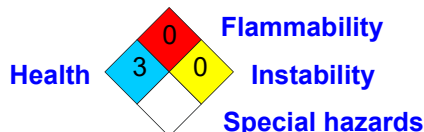
