## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

**Appropriate engineering controls** : Use only with adequate ventilation. Whether the chemicals are classified by NFPA or not, anyone using the 704 systems to classify chemicals does so at their own risk.
