## 4. First aid measures

## 5. Fire-fighting measures

### Extinguishing media

## 7. Handling and storage

### Precautions for safe handling

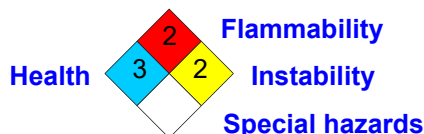
