## 2. Hazards identification

## 4. First aid measures

### Description of necessary first aid measures

### Extinguishing media

**Specific hazards arising from the chemical** : Extremely flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Bursting aerosol containers may be propelled from a fire at high speed. Runoff to sewer may create fire or explosion hazard. ## 6. Accidental release measures

### Methods and materials for containment and cleaning up

## 7. Handling and storage

### Precautions for safe handling
