## 4. First aid measures

### Description of necessary first aid measures

- Eye contact** : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention.
- Inhalation** : Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. ## 5. Fire-fighting measures

### Extinguishing media

**Suitable extinguishing media** : Use dry chemical, CO<sub>2</sub>, water spray (fog) or foam.

**Unsuitable extinguishing media** : Do not use water jet.

## 6. Accidental release measures

## 6. Accidental release measures

## 7. Handling and storage

### Precautions for safe handling

Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. - Conditions for safe storage, including any incompatibilities** : Store in accordance with local regulations. Store in a segregated and approved area.
