## 4. First aid measures

### Description of necessary first aid measures

## 4. First aid measures

## 5. Fire-fighting measures

**Special protective actions for fire-fighters** : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. ## 6. Accidental release measures
