Description of necessary first aid measures

5. Fire-fighting measures

Special protective actions for fire-fighters : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Appropriate engineering controls : Use only with adequate ventilation.
