## 4. First aid measures

### Description of necessary first aid measures

## 4. First aid measures

## 5. Fire-fighting measures

## 6. Accidental release measures

### Methods and materials for containment and cleaning up

## 7. Handling and storage

**Conditions for safe storage, including any incompatibilities** : Store in accordance with local regulations. Store in a segregated and approved area. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink.
